Uponregistration it is essential that the buyer gives his intra-community VAT number, givento him by his tax authority. If this VAT number is not supplied, MachineSpot reservesthe right to add

the local VAT to the sum of purchases and fees.

- acknowledgement of receipt in English language (provided by MachineSpot) signed by collector
