If the seller agrees to sell an item to the highest bidder despite of the fact that the reserve price was not met, the potential buyer will be informed of the decision within two days from the auction's end. Until then, the submitted offer is binding. If a lot should not have met the minimum price yet, this is mentioned in the bidding box.

If this VAT number is not supplied, MachineSpot reserves the right to add the local VAT to the sum of purchases and fees.</p> <p>2. Self collectors by car or truck (not by forwarder). For tax-free delivery we need the following documents:</p> <ul style="list-style-type: none">• excerpt from the commercial register• signed and stamped certificate of authority from the general agent to the collecting person (with the content, that the collecting person is allowed to pick



- up the purchased goods)
- copy of the passport of the collecting person
- acknowledgement of receipt in English language (provided by MachineSpot) signed by collector
