Minimum prices For some lots of the auction minimum prices have been set! Should the minimum

prices not have been reached, the seller of these items will be informed about the highest bids after the end of the auction sale. He will then decide whether the lots will be sold for the prices realized. If the seller agrees to sell an item to the highest bidder despite of the fact that the reserve price was not met, the potential buyer will be informed of the decision within two days from the auction's end. Until then, the submitted offer is binding. If a lot should not have met the minimum price yet, this is

mentioned in the bidding box.

Payment The amount must be effected to the MachineSpot bank account by / at the latest. A

cash payment is possible only at the MachineSpot office, but not at the loading points. Full payment cashed on our bank account is precondition for collection!

VAT (EU) 1. Collection by forwarder. Intra EC deliveries subject to VAT are made at zero tax.

Upon registration it is essential that the buyer gives his intra-community VAT number, given to him by his tax authority. If this VAT number is not supplied, Machine Spot reserves the right to add

the local VAT to the sum of purchases and fees.

2. Self collectors by car or truck (not by forwarder). For tax-free delivery we need

the following documents:

· excerpt from the commercial register

• signed and stamped certificate of authority from the general agent to the collecting person (with the content, that the collecting person is allowed to pick









up the purchased goods)

- · copy of the passport of the collecting person
- acknowledgement of receipt in English language (provided by MachineSpot) signed by collector

Please note that a pick-up without any of the above mentioned terms is not possible. Otherwise we have to charge the full VAT. We are asking for your appreciation.
