Upon registration it is essential that the buyer gives his intra-community VAT number, given to him by his tax authority. If this VAT number is not supplied, MachineSpot reserves the right to add the local VAT to the sum of purchases and fees.</p> <p>2. Self collectors by car or truck (not by forwarder). For tax-free delivery we need the following documents:</p> <ul style="list-style-type: none">• excerpt from the commercial register• signed and stamped certificate of authority from the general agent to the collecting person (with the content, that the collecting person is allowed to pick



- up the purchased goods)
- copy of the passport of the collecting person
- acknowledgement of receipt in English language (provided by MachineSpot) signed by collector
