2. Self collectors by car or truck (not by forwarder). For tax-free delivery we need the following documents:

- excerpt from the commercial register
- signed and stamped certificate of authority from the general agent to the



collecting person (with the content, that the collecting person is allowed to pick up the purchased goods)

- copy of the passport of the collecting person
- acknowledgement of receipt in English language (provided by MachineSpot®) signed by collector
